



Terms & Conditions:

Please note, FFACE ANOKHI is the pioneer pageant in this segment for women of all categories. We undergo a fair process of evaluation on the basis of various parameters such as beauty, talent, communication skills, leadership qualities, and of course your uniqueness. There will be relevant information shared from time to time from audition till grand finale with regards to the pageant for short-listed finalists post completion of audition process.

The general criteria for the pageant are as under:

1. Potential contestant is eligible to apply if over the age of 21
2. The Registration Charge is INR 2,999/-
3. Everyone will be allowed to appear for Final Auditions.
4. Top 20 will be chosen from the Final Auditions for National Finale and checked in to a 5 Star Property for 3 nights for workshops and grooming.
5. Contestants qualified in the top 20 will have to make a payment of INR 35,000/- for National Residential programme and Finale. This cost includes the contestants grooming, workshops, stay, and all major meals.
6. Top 10 will be chosen from the National Finale for the Grand Finale in **Thailand and crowning of FFACE ANOKHI 2019**. These 10 contestants will have to make a payment of 1,000/- USD which includes their return flights, visa, local transport, stay and all major meals in Thailand for 3 nights.

Other Terms and Conditions:

All the personal particulars of the applicant / potential contestant will be shared with judges, mentors, sponsors and the applicant / potential contestant agrees with the Pageant Organiser to give complete rights for usage of these personal particulars.

The contestant understands that she will be contracted from the date upon being selected for the pageant as a contestant and will represent the brand (organiser) and be available for any sponsor shoot and brand promotions from time to time as requested by FFACE for a minimum 12 calendar months.

The applicant / potential contestant must fit the pre-requisites of the contest they enter as stated by FFACE. The applicant / potential contestant shall make full and honest disclosure of particulars as requested FFACE ANOKHI and its associated partners. Any misrepresentation of any facts or particulars shall result in immediate disqualification.

The contestant confirms that she has not been charged or convicted in any court of law in any country and that she is not a fugitive nor is she wanted by any law enforcement agency.

The applicant / potential contestant shall not, without prior written approval of FFACE, speak to the press or any other media nor give any interviews or comments relating to the pageant or share any sensitive information related to the Pageant or Organisers or Partners or Sponsors.

The registration cost is non-refundable and the Pageant Organisers will not entertain any request on any ground whatsoever to refund the same, if the applicant or potential contestant is not chosen as one of the contestant / finalist for FFACE ANOKHI.

The decision of the Pageant Organisers / Judges / Mentors / Partners / Sponsors are final and shall not be disputed by the applicant / potential contestant. The Pageant Organisers reserve all rights at their sole discretion to select the Pageant finalists / contestants from the applicants based on their own evaluation criteria. The Pageant Organisers will not entertain any request or communication to disclose the evaluation process or reasons for selection or rejection of any applicant.

All the photographs/pictures/videos taken would be used for publicity purposes and the applicant / potential contestant agrees for the same. Any concern/queries can be raised with the organiser in writing.

The Pageant organisers and panel of judges have the liberty to replace any potential contestant / finalist with any other entry of their choice for further process in event of disqualification or release from participation.

The applicant / potential contestant indemnifies FFACE ANOKHI/the Licensee /the Promoter/any person associated with them/it's all related/affiliated companies/sponsors/judges/mentors/employees against any losses, damages, claims arising out of breach of any of the terms and conditions.

The applicant / potential contestant or any of their related party (including but not limited to spouse, children, parents, parent-inlaws, relatives) will not slander or libel other contestants, judges, Pageant, Organisers, sponsors, promoters or other stakeholders. Defamatory verbal and/or written remarks against FFACE or FFACE ANOKHI or the Licensee or the Promoter or any person associated with them on any platform will result in immediate disqualification and legal action.

In addition to the terms and conditions specified above, the applicant / potential contestant, upon being selected as a contestant / Finalist for FFACE ANOKHI, may be required to enter into further agreements with the Pageant Organisers or Partners or Sponsors at various stages to protect the interests of various stakeholders. All these terms and conditions and agreements shall be read in conjunction and will be binding on the applicant / potential contestant / contestant / Finalist.
